NURS FPX 6011 Assessment 1 Diabetes Patient Concept Map

Patients with type 2 diabetes often face multiple barriers to health and well-being. To identify these barriers and create solutions, it is important to understand the perspectives of patients/clients. To this end, the concept mapping method by Trochim was used in a community-based participatory research project. The concept map methodology uses a structured qualitative brainstorming technique to collect statements from participants and then categorizes them into groups.

The highest-rated barrier for clients was a lack of stable housing. This finding is consistent with other qualitative studies, which suggest that <u>nurs fpx 6216 budget negotiations and communication</u> who live in unstable housing situations are at higher risk of poor diabetes self-management.

Concept maps are a useful tool for organizing patient history and developing nursing diagnosis to cultivate appropriate interventions. They are also helpful for identifying patient needs and establishing priorities. This case study analyzes a patient, Carole, and describes her needs using a concept map.

NURS FPX 6103 Assessment 1 The History of Nursing Education

In the early 1800s, Florence Nightingale defied social conventions and established nursing as a professional career. Her work in the army barracks and her research on infection and the use of a lamp to illuminate sick patients transformed healthcare. Nursing has since become one of the largest and most respected health care professions. Today, nurses are involved in the management and policy deliberations of health care organizations as well as providing direct patient care.

Nursing education has evolved from an apprenticeship model to the delivery of well-designed courses in higher learning institutions. These influences and trends include the US Civil War, the establishment of hospital-

NURS FPX 6610 Assessment 4 is an assignment that asks nursing students to prepare a case presentation for stakeholders and leadership. It helps students improve their ability to present complex ideas and build a solid professional reputation. It also allows them to become proficient in delivering presentations that generate interest and buy-in, and ensure project success.

Nursing students often combine work and study, so finding enough time to write their assignments is difficult. Fortunately, there are several ways to reduce the stress of writing case studies, including starting early. When writing a case study, consider a patient scenario that involves multiple health care concerns. For example, Mrs. Snyder may have thyroid disease, heart problems, and pulmonary issues. NURS FPX 6612 Assessment 1 Triple Aim Outcome Measures

The Institute for Healthcare Improvement (IHI) has defined the Triple Aim as improving patient health, enhancing the patient experience, and reducing per capita costs. This framework provides a roadmap for fundamentally new health systems that deliver better results and create more sustainable models of care.

To accomplish this goal, the Sacred Heart Hospital leadership has chosen to implement several initiatives that will align with the Triple Aim model and improve patient outcomes. For example, the facility is moving away from the volume-based compensation system that COM FPX 3700 Assessment 2 Institutional Conflict CM providers for seeing as many patients and ordering as many tests and procedures as possible.

Administrative data profiles were populated with measures of the "health," "patient experience" and "cost" components of the Triple Aim. These included cancer screening, diabetes care and primary care-related cost measures such as physician visit and capitation costs, ED visits and potentially avoidable hospitalizations. Within each of the 17 FHTs, no consistent pattern was observed in rankings across these performance dimensions.

The PICO(T) process is an effective framework for developing a question to research (Boswell Cannon, 2015). This process helps nurses structure their initial definition of the issue they are trying to answer and the potential approach that may be useful in solving it. This can improve the accuracy and efficiency of research efforts, as well as help nurses narrow their searches and discover relevant evidence.

NURS FPX 4050 Assessment 2 Ethical and Policy Factors in Care Coordination

Governmental policies can have a huge impact on care coordination. For instance, the Affordable Care Act can impose an obligation on patients to obtain health insurance and levy fines for those who fail to comply with this policy (Regis College Online, 2021). These policies can have ethical implications for healthcare professionals.

Nurses should also be aware of national and local policies that affect patient care. These include policies that aspire to improve access to healthcare and promote value-based care. They should also be familiar with the nursing code of ethics and how they can influence patient outcomes.

ANA's ethical policy on autonomy emphasizes nurses' obligation to respect their patients' decision-making abilities. Moreover, it requires that nurses treat their patients with utmost patience and kindness. This is in line with the Hippocratic principle of primum non nocere, or "first, do no harm". This guiding principle can be used to guide nurses' decisions when coordinating care.
